



**NOTICE OF NOMINATION FOR OFFICE**

**2026 Municipal and School Board Election**

This notice is for anyone proposing to be a candidate in the Municipal Election on October 26, 2026. Section 33(1) of the *Municipal Elections Act, 1996* provides that a person may be nominated for an office by filing a nomination form in the Clerk's Office in person or by an agent. The nomination shall be in the prescribed Form 1 (Nomination Paper), signed by the person being nominated (facsimile signatures are not acceptable) and be accompanied by the prescribed nomination filing fee of \$200 for the office of Mayor or \$100 for all other offices listed herein. The filing fee may be paid only in cash, by debit card (where available), certified cheque or money order made payable to the municipality.

The nomination may be filed with the Clerk during normal office hours from May 1, 2026 to August 21, 2026 and on August 21, 2026, being Nomination Day, between 9:00 a.m. and 2:00 p.m. for the following offices:
