NOTICE of SPECIAL MEETING OF COUNCIL to formalize the creation of a new Official Plan (followed by a new Comprehensive Zoning By-Law)

Date: November 24, 2021

Time: 6:30 p.m.

Location: Council Chambers

In accordance with Section 26 (and 17) of the Planning Act, Council will be holding a Special Meeting of Council, open to the public to discuss revisions that may be required to the current (1986) Official Plan.

An Official Plan must conform with the Growth Plan for Northern Ontario, or not conflict; have regard to matters of Provincial Interest listed in Section 2 of the Planning Act; and be consistent with the Provincial Policy Statement issued under Section 3 of the Planning Act.

Council shall have regard to any written submissions about what revisions may be required and shall give any person who attends the special meeting an opportunity to be heard on that subject.

Opportunity to provide input to the Official Plan will be continuous through November & December, 2021; and again in Spring 2022 once a draft is ready for review.

THE CORPORATION OF THE TOWNSHIP OF MANITOUWADGE

BY-LAW NO. 2021 - ____

Being a By-Law to Confirm Proceedings of the Council of the Township of Manitouwadge at its Special Meeting held Wednesday, November 24, 2021.

WHEREAS Subsection 5(1) of the *Municipal Act, 2001*, as amended, provides that the powers of a municipal corporation are to be exercised by its council;

AND WHEREAS Subsection 5(3) of the said *Municipal Act* provides that all municipal power including the municipality's capacity, rights, powers and privileges under section 9, shall be exercised by by-law unless the municipality is specifically authorized to do otherwise;

AND WHEREAS it is deemed expedient that the proceedings of the Council of the Township of Manitouwadge at this meeting be confirmed and adopted by by-law;

NOW THEREFORE the Council of the Township of Manitouwadge enacts as follows:

1. **THAT** the action of the Council of the Township of Manitouwadge in respect of each recommendation or resolution contained in the minutes of the special council meeting of Wednesday, November 24, 2021 and any reports of committees and of local boards and each motion and resolution passed and other action taken by the Council of the Township of Manitouwadge at this meeting is hereby adopted and confirmed as if all such proceedings were expressly embodied in this by-law.
2. **THAT** the Mayor and the appropriate officials of the Township of Manitouwadge are hereby authorized and directed to do all things necessary to give effect to the action of the Council of the Township of Manitouwadge referred to in the proceeding section.
3. **THAT** the Mayor, or in the absence of the Mayor, the alternate head of council and the Municipal Clerk, or in the absence of the Municipal Clerk, the Acting Clerk, are authorized and directed to execute all documents necessary in that behalf and to affix thereto the corporate seal of the Township of Manitouwadge.
